1. Executive Summary

This document is the first version of the Dissemination and Exploitation Plan for the SAUCE Project.

Designed to provide tracking of the plan for dissemination of SAUCE outcomes, the Use of Knowledge and IPR Management Strategy, for the duration of the project. The Dissemination and Exploitation Plan provides an outline and log of the work carried out for the three Tasks of Work Package 9: WP9T1 Industry Exploitation, WP9T2 Dissemination and Demonstration, WP9T3 Specification Design and Demonstration. This work package is designed to make the bridge between the RTD work and external Industry professionals, addressing communities of digital post-production companies in the film, advertising and broadcast markets; games developers; film studios; post-production software and media plug-in developers; Open standards users; and the ICT research community.

This deliverable provides further information on the initial PR material, lists of dissemination activities such as trade fairs, conferences, showcase events and workshops and details of publications. It also highlights the IPR Management Strategy.

This first version of the Plan reflects the path for dissemination and IPR Management as foreseen at start of the project. An updated version (D9.4) will be produced at the end of M24 (December 2019) and final deliverables D9.6 and D9.7 will close the project at M36 (December 2020).
